The Cornwall Council (Addition of Public Footpath at Forge in the Parishes of Ladock and Probus) Modification Order 2026

Confirmation of Definitive Map Modification Order

The abovementioned Order was made by Cornwall Council on 3rd March 2026 under Section 53(2)(b) of the Wildlife and Countryside Act 1981. The Order was subsequently confirmed by Cornwall Council on 12th May 2026. As required by Paragraphs 11(1), (2) and (3) of Schedule 15 to the Wildlife and Countryside Act 1981, Cornwall Council hereby gives notice of the confirmation of the Order.

The Order came into force on the day that it was confirmed. From that date the Public Footpaths added to the Definitive Map and Statement by the Order existed as highways.

A copy of the required Notice and a copy of the Order as confirmed are enclosed. Please note that any applications to the High Court in respect of the validity of the Order or the statutory procedures must be made in the required manner within six weeks of the date of the Notice.

On 12th May 2026, Cornwall Council confirmed the above Order made under section 53(2)(b) of the Wildlife and Countryside Act 1981. The effect of the Order as confirmed is to modify the Definitive Map and Statement for the area by adding a length of Public Footpath in the Parish of Ladock commencing at its junction with existing Public Footpath 4 Ladock approximately 219 metres south-south-west of 'Forgue Farm Cottage' at Ordnance Survey Grid Reference (OSGR) SW 8900/4990 shown as point "A" on the Order map and continuing in a generally north-north-easterly direction for a distance of 33 metres and terminating at its junction with existing Public Footpath 3 Ladock approximately 187 metres south of 'Forgue Farm Cottage' at OSGR SW 8901/4993 shown as point "B" on the Order map and by adding a length of Public Footpath in the Parish of Probus commencing at its junction with existing Public Footpath 3 Ladock approximately 194 metres south of 'Forgue Farm Cottage' at OSGR SW 8903/4992 shown as point "C" on the Order map and continuing in a generally east-south-easterly direction for a distance of 67 metres and terminating at its junction with Classified Road B3275 approximately 228 metres south-south-east of 'Forgue Farm Cottage' at OSGR SW 8909/4989 shown as point "D" on the Order map.

The Order came into force on the day that it was confirmed but if any person aggrieved by the Order wants to question its validity on the ground that that it is not within the powers of Section 53 of the Wildlife and Countryside Act 1981, or on the ground that any requirement of Schedule 15 of the Act has not been complied with in relation to the Order, he or she may under paragraph 12 (1) of Schedule 15 to the Act within six weeks from the date of this Notice, make application to the High Court.

This Order is made by Cornwall Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the definitive map and statement of public rights of way for the former Carrick District area require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery of evidence which (when considered with all other relevant available evidence) shows that rights of way which are not shown in the map and statement subsists or are reasonably alleged to subsist over land in the area to which the map relates.

The Cornwall Council hereby order that:

1. For the purposes of this Order the relevant date is 10 February 2026.
2. The Definitive Map and Statement of Public Rights of Way for the former Carrick District area shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as, "The Cornwall Council (Addition of Public Footpaths at Forgue in the Parishes of Ladock and Probus) Modification Order 2026".

Modification of Definitive Map

Description of Path or Way to be Added

A length of Public Footpath in the Parish of Ladock commencing at its junction with existing Public Footpath 4 Ladock approximately 219 metres south-south-west of 'Forgue Farm Cottage' at Ordnance Survey Grid Reference (OSGR) SW 8900/4990 shown as point "A" on the attached Order map and continuing in a generally north-north-easterly direction for a distance of 33 metres and terminating at its junction with existing Public Footpath 3 Ladock approximately 187 metres south of 'Forgue Farm Cottage' at OSGR SW 8901/4993 shown as point "B" on the attached Order map.

A length of Public Footpath in the Parish of Probus commencing at its junction with existing Public Footpath 3 Ladock approximately 194 metres south of 'Forgue Farm Cottage' at OSGR SW 8903/4992 shown as point "C" on the attached Order map and continuing in a generally east-south-easterly direction for a distance of 67 metres and terminating at its junction with Classified Road B3275 approximately 228 metres south-south-east of 'Forgue Farm Cottage' at OSGR SW 8909/4989 shown as point "D" on the attached Order map.

The total length of Public Footpath to be added to the Definitive Map is 100 metres. The width of the Public Footpaths varies between 2 (two) metres and 6 (six) metres as described in the User Evidence Forms submitted with the Definitive Map Modification Order application.

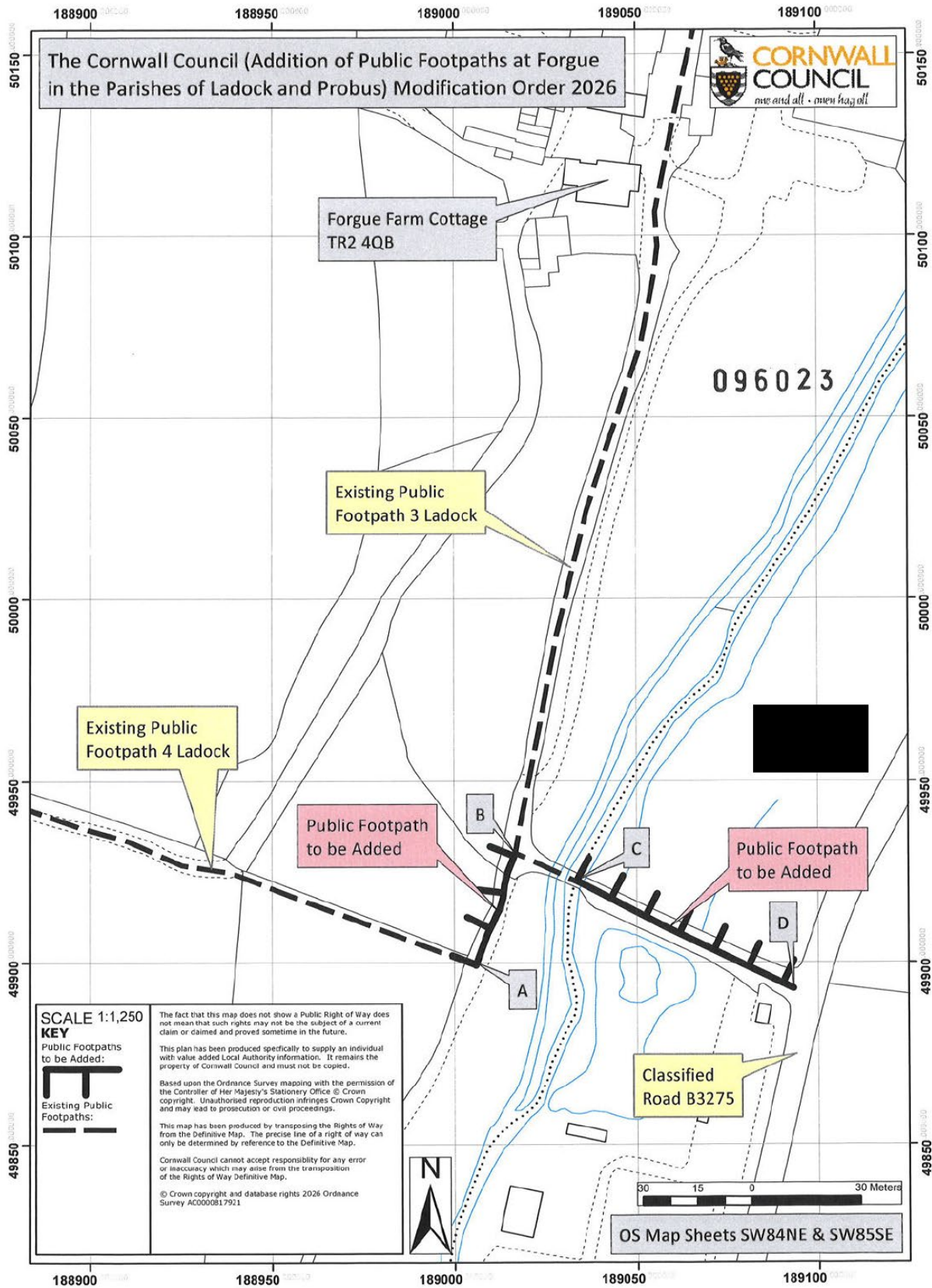
